    - We have a clean audit.
    - The financial statements fairly represent the current financial position of the BIA.

- It was moved by Melissa Hope to approve Vanderluit & Associates as the HxBIA auditors for the 2017-18 budget year. Motion seconded by Adam Cameron. Motion passed unanimously.

# 8. **Message from the Chair**

- Safety and security have been top priority
  - New Safety Committee established with Cindy MacMillan chairing.
  - De-escalation & naloxone training happening every 3 months
- Signature event: Experience Hastings Crossing
- Major public art investments

#### 9. Executive Director's Report

- Landon Hoyt provided his executive director's report with the handout provided to all guests.
- An update on safety & security, including 53,321 needles picked up since August 2016
- Highlighted several events, sponsorships, and marketing that has taken place this past year.
- And update on the CommunityWise program and efforts being made to integrate businesses into the DTES community.
- Experience Hastings Crossing event has won a provincial and international award!
  - Currently planning for next year's event with plans to expand upon and grow partnerships.

- Highlights of some of the BIA's community advocacy and involvement, including our work with the City's CED Strategic Action Committee, the BIA Partnership, and Urban Core.
- A new CRM system with Directory, Event, BIA Member Benefits, and other
  capabilities is being rolled out, so make sure members look for an email in their
  inboxes soon to update their business profiles and stay updated on BIA related
  matters.
- Landon also encouraged members to get involved in committees to help drive the activities of the BIA.
- New staff person through the LEDlab
  - David Harris-Koblin introduced himself and gave an overview of the work he is doing.

## 10. **2017-18 Budget**

- Discussion on the proposed budget.
- Minor details to point out for the upcoming year:
  - Slight increase in rent costs. This is an estimate in case a partnership with HiVE is discontinued.
  - Increase in Safety and Wellbeing costs, which includes our MP Neighbours Patrol. There are plans in the works to increase this service moving forward to deal with current safety concerns.
  - Public Art and Placemaking was reduced and moved to Safety budget because this is something that is easier to fund through grants and partnerships as opposed to safety.
- It was moved by Melissa Hope to approve the 2018-19 budget as presented. Motion seconded by Drew Ratcliffe. Motion passed unanimously.

#### 11. Election of Directors

- Jon Sharun gave an overview of the HxBIA by-laws concerning the election of board members.
  - HxBIA must have a minimum of 7 and a maximum of 15 board directors. We currently have 10 board members. If we are over the limit of 15 directors with additional nominees, we would need to hold an election to fill only the 15 seats.
